## USAMU Soldiers Seize Six Gold, Four Silver, & Two Bronze Medals at USA Shooting National Championship

U.S. Army Marksmanship Unit Soldiers won National Champion titles in six of the eight rifle matches at USA Shooting's 2023 Rifle National Championships at Fort Moore, Georgia June 1-10. In addition to the six Gold Medals, USAMU Soldiers also earned four Silver and two Bronze Medals.

The Soldiers, who are all marksmanship instructors/competitive shooters with the USAMU International Rifle Team, competed in Nationals not only for medals and titles, but also for critical selection points in Part One of the 2023 Pan American Games Selection Match and Part Two of the 2023 ParaPan Games Selection Match.

2020 Olympian and 2022 National Air Rifle Champion, Sgt. Sagen Maddalena, knew Nationals would be challenging but was looking forward to the opportunity to compete on her home turf while hopefully claiming another National Champion title. "I knew the competition would be tough. We had a handful of world-class marksmen and some up-and-coming junior competitors," said the Groveland, California native. After two days of qualification relays against 84 other competitors from across the United States, Maddalena earned a spot into the Women's 10m Air Rifle Final with a score of 1262.9, just 1.5 points behind 2020 Olympic Silver Medalist, Mary Tucker. Fellow USAMU teammate and 2020 Olympian, Sgt. Alison Weisz, also earned her way into the Final. Once in the Final, Maddalena said she relied on her training to seize the Gold Medal and the 2023 Women's 10m Air Rifle Champion title with a Final score of 251.3 over Tucker's 249.2. Molly McGhin took the Bronze Medal and Weisz finished in seventh. "Shooting the Air Rifle Final, I felt in complete control of my shot process. I was confident in my ability to execute good shots and ended up a two-time National Champion! I felt happy with my achievement and it showed me that my preparation paid off." Of course, the bonus to winning her second consecutive National Air Rifle Champion title was that she had an extra cheering squad besides her USAMU teammates. "What's better, my mother was there to watch and cheer me on!"

In Men's 10m Air Rifle, 54 of the top American marksmen vied for the top eight spots so they could compete in the Final for a chance at the Gold. Four USAMU Soldiers (Sgt. Tim Sherry, Sgt. Ivan Roe, Spc. Jared Eddy and Sgt. Brandon Muske) earned spots in the Final with their solid qualification scores. The competitive Final quickly weaned the field down and ended in an intense battle for Gold between Muske and 2020 Olympic Silver Medalist Lucas Kozeniesky. It was so close that the Gold and Silver Medals were separated by only .2 points, so Muske said it was a little surreal that he won. "Going into the last shot, I knew I needed to shoot a deep shot, and even then, I figured Lucas would probably still win as he is a very accomplished finals shooter and had the lead. After we both shot, I looked at some of my teammates, and they were giving me a thumbs up, but I wasn't sure exactly what that meant in the moment until I heard the announcer say that Lucas had finished in second place, meaning I must have won!" With such a close win, the Brenham, Texas native said he was excited to be named the 2023 Men's 10m Air Rifle Champion. "I am very happy with my performance and am happy it was enough to win."

In the para R3/SH1 10m Mixed Prone Air Rifle Match, Purple Heart recipient Staff Sgt. Kevin Nguyen claimed the Gold Medal and National title with a score of 1263.5-114x.

In Women's 50m Smallbore, Maddalena and Weisz both earned their way into the Final, beating out 62 other competitors. In fact, Maddalena led the qualification relays with the high score of 1178-77x, which set her up perfectly for her next goal, to win Gold. In 2022, Maddalena won both the Air Rifle and Smallbore National Champion titles, something no one else has accomplished, according to USA Shooting. So with the Air Rifle Gold Medal in hand, the Soldier said she was definitely seeking to make another record - double champion for two consecutive years.

## USAMU Commander's Report



Military Marksmanship Association Members,

Happy 4th of July to my fellow MMA members. I hope you all had a relaxing day with family and friends, partook in family culinary traditions, enjoyed a beverage of choice, and celebrated the birth of our independence.

As always, the summer is a busy time for the USAMU. Most notably are the upcoming Small Arms Firing Schools and National Matches at Camp Perry in conjunction with our CMP teammates which will see a good portion of the formation engaged for most of July. Stay tuned for the next issue to read about individual and team successes after the National Matches are complete.

In the lead up to the National Matches, the Service Rifle team turned in one of the most dominant performances in recent Interservice Rifle Championship history. SSG Cleland won his 5th Interservice Individual Championship and his 2nd Long Range Individual Title. Additionally, the SR team won all five of the team events and five of the six individual aggregate competitions.

The International Rifle team also crushed the competition during the USA Shooting National Championships which were held at our home range on Fort Moore, GA this year. One of the USAMU's newest team members, SPC Eddy, won his first ever national championship in Men's 50m Smallbore and SSG Muske joined him in winning his first national championship in Men's 10m Air Rifle. SGT Maddalena claimed her second national title in the Women's 10M Air Rifle while SGT Sherry placed first in all three (Free Rifle, Prone, Standard Rifle) 300m events.

The International Rifle team also crushed the competition during the USA Shooting National Championships which were held at our home range on Fort Moore, GA this year. One of the USAMU's newest team members, SPC Eddy, won his first ever national championship in Men's 50m Smallbore and SSG Muske joined him in winning his first national championship in Men's 10m Air Rifle. SGT Maddalena claimed her second national title in the Women's 10M Air Rifle while SGT Sherry placed first in all three (Free Rifle, Prone, Standard Rifle) 300m events.

Continuing the trend of dominant performances, the USAMU Shotgun team is packing them in on the U.S. National Shotgun Team. At the conclusion of two selection matches, the SG team holds 4 of 6 slots on Men's Skeet, 1 of 6 on Women's Skeet, 5 of 6 on Men's Trap, and 2 of 6 on Women's Trap. That equates to 50% of the U.S. National Team being comprised of USAMU shooters and of note, we only have three women shooters on the SG team and they are all on the National Team.

I look forward to the next issue to share more winning performances from the USAMU Service Pistol and Action Shooting teams as well as highlight the important lethality training provided by the Instructor Training Group.

**MEET MMA PAST VICE PRESIDENT**

SFC Nicole Allaire Haggman



SFC Nicole Haggman is currently serving as the USAMU Operations NCOIC. She joined the Army in August of 2004 after finishing her college shooting career. SFC Haggman grew up Kearny, NJ where she learned to shoot from her father.

From 1999-2001 she shot for the University of Nebraska-Lincoln, where her freshman year she was crowned NCAA Champion in smallbore. From 2001-2004 she attended West Virginia University and earned her Bachelorette of Science in Sports and Exercise Psychology. During her college career she was named an 8 time All-American (4 times in smallbore and 4 times in air rifle).

In 2004 she went off to Basic Combat Training and AIT in Ft. Leonard Wood, MO and then reported to the International Rifle Section of the USAMU. In 2006 she made the World Championship Team where the three-person team she was on won the gold medal and set a new World record in Women's 300M Prone. She earned the Distinguished International Shooter Badge. After being in the Unit a few years the Command Sergeant Major (CSM) at the time brought her up to the S3 shop where she served at the USAMU Land and School NCO.

In 2011 the USAMU brought back the Instructor Training Group (ITG) and she was moved there to run operations and supported the professional development of Army instructors; identified training needs, coordinated instructor courses, workshops, and certifications, and facilitated ongoing learning opportunities to enhance instructors' instructional skills, subject matter expertise, and teaching methodologies. After that she coached the USAMU Paralympic Rifle and Pistol Team where she worked closely with individual athletes or a team of athletes to identify their strengths and weaknesses, set goals, and create personalized training plans; monitored progress, track performance metrics, and provide feedback and support to help athletes reach their full potential.

In 2013 when she was promoted to Sergeant First Class she was moved back to the S3 and became the Operations NCOIC and will finish her career there on 1 September 2024. She participates in the planning process, working with senior leaders, high level officers, staff officers, and other stakeholders to develop operational plans and strategies. She contributes to the development of mission objectives, determines available resources, and develops timelines and task assignments.

She is married to SFC Michael Haggman who is on the USAMU's Instructor Training Group and has 1 son, Charles. She served as the MMA Vice President January 2016 to November 2021 and is still serving on the MMA Executive Board as the Past Vice President.

"I was aiming for a double National Champ with smallbore also. Unfortunately I allowed the thought to occupy my headspace while I should have been keeping a clear head. I dipped my last shot, giving me the Silver Medal." (Cecelia Ossi won the Gold and McGhin took the Bronze.) Though her personal goal was not met, Maddalena said it was a valuable reminder nonetheless. "Taking the Silver reminds me that nothing is a given – meaning training doesn't stop because of success, and each shot holds value—no matter how far ahead or behind I am in the competition."

In Men's 50m Smallbore, Eddy, Roe, Sherry and Sgt. Jared Desrosiers shot qualifying scores that earned them placement into the Final out of a field of 55 total athletes. In fact, Sherry lead the qualifying relays with a score of 1183-73x. After moving through all the positions (kneeling, prone and standing), the USAMU Soldiers shot their way to the top of the Final. Eddy, Roe and Sherry swept the podium claiming the Gold, Silver and Bronze respectively. Eddy said the Championships was challenging and exciting due to all the great competitors. And since he just arrived at the Home of Champions in February, the Columbus, Georgia native was relieved his training paid off. "I am happy to start my USAMU journey on a good note." For Olympic hopeful athletes, earning anything but the Gold can be a mix of emotions though, said Sherry, an Evergreen, Colorado native. "It's tough having such a strong match and not walking away with the outcome that I wanted in either air rifle or smallbore. I am proud of my performance though, and am looking forward to working on my finals performance and pressure training." Of course, seeing your teammates win Gold and National titles makes the situation that much easier to take, explained Sherry. "Although I didn't have the outcome I was looking for, it was great to see my teammates on the top step of both men's podiums! I enjoyed helping sweep the men's smallbore podium too."

The final event for the USAMU Soldiers at Nationals was the 50m Prone Rifle Match. Though this course of fire is not an Olympic event anymore, it is still held at various international events like the World Championships. The Fort Moore Soldiers continued to perform excellently and claimed the Gold Medals and National titles in both the men's and women's categories. Maddalena claimed her second Gold and National Champion title in the Championships when she won the 50m Prone Rifle Match with a two-day score of 1240.9. Roe, a Bozeman, Montana native, led the men when he seized the Gold with a 1249.1 while Sherry and Staff Sgt. Patrick Sunderman completed the podium, for another USAMU sweep, with their scores of 1247.7 and 1247.5, respectively.

In the para R6/SH1 50m Mixed Prone Rifle, Nguyen had to settle for the Silver Medal behind fellow U.S. Army World Class Athlete Program athlete and USAMU alumnus, Sgt. 1st Class John Joss, who won the Gold.

The overall strong performances by the Soldiers not only earned them medals and titles, but an invitation to Part Two of the Pan American Games Selection Match in July. Both Weisz and Maddalena's performances earned them spots to compete in both 10m air rifle and 50m smallbore. Eddy, Roe, Muske and Sherry qualified to compete in 10m air rifle. And Eddy, Roe, Sherry and Desrosiers were invited to compete in 50m smallbore. Part Two of the Pan American Games Selection Match will be at the USA Shooting headquarters in Colorado Springs, Colorado in July 6-11. Part Three of the 2023 ParaPan Games Selection Match will be July 29 - August 3. Story by Lt. Col. Michelle Lunato

At the USA Shooting 300-Meter Rifle Nationals held May 23-27, U.S. Army Sgt. Tim Sherry won three Gold Medals. The Evergreen, Colorado native, who is a marksmanship instructor/competitive shooter with the U.S. Army Marksmanship Unit International Rifle Team, claimed the wins in Men's 300-Meter Prone Rifle, Open 300-Meter Standard Rifle and Men's 300-Meter Three-Position Rifle against top marksmen from across the United States.

# 2023 USAMU Hall of Fame Inductees Announced

We are excited to announce the newest shooters selected to the U. S. Army Marksmanship Unit (USAMU) Hall of Fame include MAJ (Ret) Michael E. Anti, LTC (Ret) Wanda R. Jewell and COL (Ret) Bruce A. Meredith.

The purpose of the USAMU Hall of Fame is to recognize those individuals who served their country and the U. S. Army Marksmanship Unit in a truly exemplary manner. All individuals that are in a Shooting Section Hall of Fame or the Support Hall of Fame and have been retired from their primary competitive sport for five years are considered for the ballot. Induction in the USAMU Hall of Fame is by vote of Military Marksmanship Association members for the top three of the 25 candidates on the ballot.

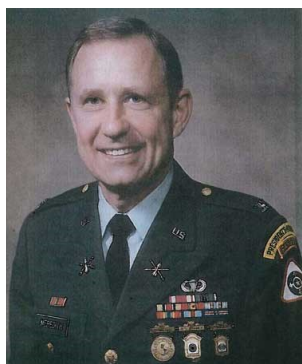
The induction ceremony will take place on Friday, October 13, 2023 at the Tommy Pool International Shooting Complex on Fort Moore, GA. There will also be an induction of COL (Ret) Stanley J. Parmentier into the USAMU Support Hall of Fame. The dedication of the Pullum Finals Hall, named after LTC (Ret) William C. Pullum, will also take place. We are hoping that the approval to name the 50 meter/300 meter range building after LTC (Ret) Lones W. Wigger, Jr. will occur in time so that dedication can also be done. Please join us.



**Michael E. Anti** competed at the 1992, 2000, 2004 and 2008 Olympics in 50-meter smallbore rifle events and was the Olympic Silver Medalist in the 50-meter 3-position rifle event in 2004 in Athens. He competed in the 1982 World Shooting Championships winning a team medal and earned the Distinguished International Shooter Badge before even starting college. He won gold and silver individual medals at the 1991 Pan American Games and won World Cups in 2000 and 2008. He was the World Cup Finals Silver Medalist in 2000. He won five National Championships. He competed in three Championships of the Americas, three World Shooting Championships and two Pan American Games winning numerous medals. He retired in 2008 and in 2009 he became Assistant Rifle Coach at the United States Air Force Academy. In 2017 he became the Head Rifle Coach at the United States Naval Academy.



**Wanda R. Jewell** was the 1984 Olympic Bronze Medalist in Women's 3-Position Rifle in Los Angeles. She competed in seven consecutive World Shooting Championships (1974, 1978, 1982, 1986, 1990, 1994, 1998) and was World Champion in Women's 3-Position Rifle and Women's Air Rifle in 1978 in Seoul. She holds the distinction of being the first woman in history to win two World Championship titles at the same competition. In 1979 she was the World Air Gun Championships Silver Medalist in Women's Air Rifle. Wanda is one of the few USA women shooters to have earned a position on an USA "Open" Team as she made the 1979 Pan American Games Team in Air Rifle before there were separate women events in the Pan American Games shooting events. She earned the Distinguished International Shooter Badge. Wanda also competed in the Pan American Games in 1983, 1987 and 1995 and Championships of the Americas in 1981. She served as the USAMU S-1 and then as the USA Shooting National Rifle Coach and the USA Shooting Director of Operations. She is currently serving on the ISSF Rifle Committee.



**Bruce A. Meredith** competed in UIT/ISSF Championships for the USA from 1967-1986, competing in 40 nations. He won the National Smallbore Rifle Prone Championship in 1967 and shot the first prone any-sight 3200 x 3200. At the 1967 Pan American Games he won two team gold medals and a team World Record and earned the Distinguished International Shooting Badge. He won a team medal in the 1970 World Shooting Championships in 300m Standard Rifle 3-Position and competed in 300m rifle prone in the 1986 World Shooting Championships. He then competed for the U. S. Virgin Islands 1987 to 2010 including four Olympic Games, four World Shooting Championships, four Championships of the Americas, three Pan American Games. and numerous World Cups. He has Distinguished Badges in Rifle, Pistol, International, NRA Smallbore Rifle Prone, NRA Smallbore Rifle Position, NRA International Smallbore Rifle and Modern Crossbow. He earned the President's Hundred Tab in both rifle and pistol. He has served as the President of the Military Marksmanship Association during the very successful 50th Anniversary of the USAMU in 2006 and is the current MMA Historian.

Bruce left Active Duty at the USAMU as a Major and was the Officer in Charge and Team Captain of the U. S. Army Reserve International Team (International Rifle and Running Target) from 1968 to 1986, eventually retiring as a Colonel in 1991. Bruce provided former USAMU shooters an opportunity to continue to excel after they left Active Duty as there was no Unit of Choice, no way to stabilize enlisted soldiers for 20 years and no World Class Athlete Program (WCAP) back then. He managed a team of 84 former USAMU rifle shooters such as Gary Anderson, John Writer, Margaret Murdock, Tommy Pool, John Foster, Dennis Dingman, Thurston Banks, Boyd Goldsby, David Kimes, David Ross III, David Cramer, Don Harmon, Mike Griggs, Vic Auer, Bill Rigby, Sue Mitchell, Lanny Bassham, Edward Etzel, Ray Carter, Mike Theimer, Wanda Jewell, Karen Monez, Sue Ann Sandusky, Mike Theimer, William Beard, Robert Mitchell, Ernest Vande Zande, Kurt Fitz-Randolph, Michael Anti, David Johnson, Gloria Parmentier, Phil Whitworth, Randy Stewart, Tony Leone, Denise Loring, Troy Baker, Mary Godlove, and Eric Uptagrafft actually spent some or most of their career on the USAR International Rifle Team thanks to Bruce Meredith's work in providing the budget, training, gunsmith support, ammunition and organization. During the period that he was the OIC his shooters won a total of 105 medals for the USA in the Olympic Games, World Shooting Championships, Pan American Games and the Championships of the Americas.

# WHERE ARE THEY NOW

## SGM (Ret.) Emil Heugatter



SGM (Ret) Emil Heugatter (MMA Life Member) had a great career as a soldier and competitive pistol shooter. He has earned the Distinguished Pistol Shot Badge, the Distinguished International Shooter Badge and the President's Hundred tab. He is in the USAMU Hall of Fame, the USAMU International Pistol Hall of Fame and the USAMU Service Pistol Hall of Fame.

He joined the Texas National Guard at age 16 and went on active duty in 1954. His first assignment after Basic and AIT was Fort William Davis, Panama Canal Zone. Over the years he has had duty at Fort Ord, Fort Knox, Fort Benning, Korea, Fort Riley, Germany, Vietnam, and West Point, NY as the Coach of the USMA Pistol Team 1972 to 1976.

He earned the Distinguished Pistol Shot Badge with the USARCAR-IB/Panama team in 1957 at Camp Perry with the 1911 .45 hardball pistol. He won the National Center Fire Championship in 1958 shooting a .38 revolver, probably the last time that has been done as everyone changed to .38 automatics afterwards. Most of 1960 was an assignment with the 7th Infantry Division, Camp Casey, Korea. He returned from Korea in February 1961 to be assigned to 6th Army

AMU, Fort Ord. The Berlin Wall went up in 1961. Heugatter was sent to train at Fort Knox on the Davy Crockett nuclear weapon system and then went to Germany. From 1962 to 1965 he was with the 3rd Armored Cav and USAEUR pistol team highlighted by a 297x300 hardball score at All Army in 1962. He was assigned to the AMU 1965 to 1969, 1970 to 1972 and 1976 to 1979. He was a member of the Army Blue Team with teammates Anderson, Blankenship, Thompson, Jones, Whitaker, Clark, Harmon and others. They were National Champions setting numerous National Records many years and the strongest competitors were the Air Force and Marines. The Army Blue Pistol Team ruled the annual Florida Mid-Winters.

He earned the Distinguished International Shooter Badge at the 1966 World Shooting Championships in Germany firing on the USA Center Fire Pistol team that won gold. He also shot Air Pistol and Free Pistol in the 1970 World Championships in Phoenix, AZ, Free Pistol in the 1971 Pan American Games in Cali, Columbia and Free Pistol in the 1973 Championships of the Americas in Mexico City. While in Vietnam in 1969 he was with the 9th Infantry Division Sniper School and then was the NCOIC of the 25th Infantry Division Sniper School. His decorations include the MSM, CIB, Bronze Star with OLC, ARCOM with 2 OLC, Vietnam Service Medal with 3 Bronze Stars, Vietnam Campaign Medal, Presidents Hundred Tab. After retiring in 1979 as a Sergeant Major, he continued service to his country by working at the U. S. Postal Service in Waco, TX until 1996.

He thanks the greatest gunsmith ever (Jack Maple), his coaches (Oscar Weinmeister and Aubrey Smith) and the leadership (Red Mosely). He lost his wife of 62 years, Bonnie, 16 January 2022. She was the perfect Army Wife. She wrote him every day that he was stationed in Korea and Vietnam. We all look forward to seeing "Gater" 13-14 October at the USAMU Reunion.
