USAMU welcomes new commander

FORT BENNING, Ga. — Soldiers, civilians, friends and family members of the U.S. Army Marksmanship Unit (USAMU) welcomed a new commander on Tuesday, June 24th to the 'Home of Champions.'

Lt. Col. Bret Tecklenburg assumed command from Lt. Col. Don King Jr. at the unit's Ceremony Hill located adjacent to Pool Range Complex. King, who commanded the unit for two years, is headed to the John F. Kennedy Special Warfare Center and School as the executive officer to the commanding general.

"The AMU is the home of champions," said Tecklenburg. "I am honored to serve in this organization with these phenomenal men and women. I am humbled to be a small part of the legacy this unit has established."

Tecklenburg becomes the 21st commander of the USAMU after his tenure as the branch chief, division chief and operations planner at the Joint Special Operations Command.

He enlisted into the Army as a UH-1 helicopter crew chief and mechanic. He was commissioned in 1996 and served in a multitude of leadership positions throughout his military career. He deployed numerous times in support of overseas contingency operations, including multiple deployments to Iraq and Afghanistan, serving in both infantry and special operations

Coats Brown Legacy

This series is about the life and times of a shooting legend. If you shot or worked with or for Coats Brown, please send any memories you have of those times to the Editor so the membership can share or relive those memories.

In 1958 one of the scheduled away matches for his team was held at Fort Dix, New York. Coats decided to visit an old friend when the match was finished and he was enroute back to Fort Niagara. BG Throckmorton had asked Joe Benner to tell Coats "If he came by that way, stop in and say hello". BG Throckmorton was now the Commandant of Cadets at the U.S. Military Academy at West Point, New York. As a young officer, Throckmorton had been a teammate of Coats in the 30's and had shot very well, competing as a member of the winning Infantry Team in the National Trophy Team Match. Coats and young Throckmorton had talked a lot as teammates. Coats knew him to be a very serious man. He would help you if he could. He treated Coats as an equal. Coats knew this hard working man would someday become a general officer. Coats asked the MP on duty at the USMA Thayer Gate for directions. He does not remember where he parked, but he was directed to the Commandants Office above the Plain. Coats spoke to the adjutant who informed him the general would return in minutes and please have a seat. Soon the General returned, saw Coats and said "Well I'll be doggoned Brown, How are you, Come on in and let's talk". They chatted for half an hour or so. They talked about the old team, the officers who made the team great, their friends who were lost during the war, a few shooting stories, a few funny happenings, they reminisced and laughed. It was a good visit to an old friend. The adjutant commented as Coats was leaving, "That was the first time he heard the general laugh". General Throckmorton went on to become CG of the Strategic Army Command at MacDill Air Force Base, Florida. He retired as a four star.

In 1958 the Army Team competed at Cape May, New Jersey at the Coast Guard Range. Ellis Williams was a very fine rapid-fire shooter. At Cape May, Ellis creedmoored his opponents and won the sitting rapid-fire match by shooting five consecutive perfect strings including refires on the old 6" V ring target. Kenner Ravencraft remembers shooting a tight group sitting during an important match that summer and was scored a 45. Cracker was depressed after losing the challenge for a keyholed shot. Coach observed Ravencraft's discomfort and went to advise him. Coach Brown told Cracker "Don't worry about it, it is out of your control". "Concentrate on what's

to come". "You have a lot of shooting yet to do". Coats remembers a rifle match fired at Claremore, Oklahoma when it got dark before completion of the final relay and Loyd Crow shot an amazing score anyway.

Loyd described the event as a 1000 yard string and part of the grand aggregate. He was the last firer because the relays infiltrated and the shooters on his point were slow. There was no wind at that time of day, it was dead still, but it was getting dark. Loyd could see the crosshairs of his scope for the first four shots. With oncoming darkness he centered the target frame in the scope reticle without benefit of crosshairs and released the shot. The muzzle flash would illuminate the crosshairs, it seems prior to recoil and Loyd could give extremely accurate calls and became very comfortable with this technique. Loyd called his final shot a V at 7 O'clock. The pit detail could not find the shot until they removed the target and examined it under electric lights in the target shed. It was a V at 7 and Loyd Crow had cleaned the 1000 yard string. A couple of interesting points stand out about the city of Claremore. The town had a Will Rogers Memorial Building. The Mason Hotel where the Rifle Team stayed and ate their meals, housed the Davis Gun Collection. The collection consisted of 25,000 guns of all types, sizes, and descriptions that were displayed in glass cases or hung on the walls of the lobby and walls of all floors of the hotel. There were no duplicate guns in this collection of 25,000.

Bruce Meredith receives award

Bruce Meredith, Past President and first Life Member of the MMA, was presented the International Shooting Sports Federation highest award, The President's Order with Diploma of Honor, at the World Cup Shooting event at Fort Benning in April 2014. The presentation was made by the ISSF President, Olegario Vazquez Rana of Mexico and Franz Schreiber, ISSF General Secretary of Germany. The award was for more than 50 years of competition, loyalty, devotion and outstanding contributions to the sport of competitive shooting. His first competitive events were the High Power Rifle Championships, Camp Perry, Ohio in 1958, and his last the USA Shooting Olympic Spring Selection Match at Fort Benning in 2010. Col Meredith is President's 100 in both rifle and pistol. He competed with the U.S. Army, the U.S., and U.S. Virgin Islands. At age 63, he was the oldest competitor in any sport at the 2000 Sydney Olympics. He also competed in the Olympics in Seoul 1988, Barcelona in 1992, Atlanta in 1996, and coached in Athens in 2004. He is the only shooter distinguished in six disciplines – Rifle, Pistol, International, SB Rifle Prone, SB Rifle Position and Modern Crossbow.. He was invited as a VIP guest of the ISSF President to the 2010 World Championships in Germany. He has competed in 41 nations and traveled to 50 states and 102 nations. He has served on committees with the NRA, the ISSF and the CMP.

assignments.

To serve as the leader of the AMU is an exclusive opportunity for any officer who assumes battalion command for the first time, said Col. Brian Cavanaugh, commander of the Army Accessions Support Brigade and reviewing officer.

"The (AMU) is unique in both the value that it provides to the Army and in its organization and structure," said Cavanaugh. "When you have the professional excellence of the people in the AMU you can achieve so much more than a counterpart with a large staff."

King led the unit through both exciting and challenging times. Under his leadership the unit sent seven Soldiers to the London Olympics in 2012 and also saw the creation of the unit's Paralympic team. He also guided the unit through fiscal constraints in 2013, finding innovative ways to train and maintain the right balance of capabilities to sustain the unit's unique mission. Under his leadership, the unit raised marksmanship proficiency Army-wide and upheld its tradition in competition, including winning every Interservice individual and team championship, said Command Sgt. Maj. William Koller.

"It's really tough to leave this place because of the professionalism displayed every day by the Soldiers and civilians here," King said. "They touch all aspects of the Army and are truly the best in the entire Department of Defense at what they do. It's tough to walk away from that, but I'll always remember the extraordinary people who make up this battalion and know our Army is better off because of this unit."

USAMU is part of the U.S. Army Accessions Support Brigade, Army Marketing and Research Group and is tasked with enhancing the Army's recruiting effort, raising the standard of Army marksmanship and furthering small arms research and development to enhance the Army's overall combat readiness.
